### The Jordanian State Security Court Issued its Unjust Judgment Against Ustaadh Saeed Radwan Abu Emad, Member of Hizb ut Tahrir

(Translated)

In continuation of the unjust methods practiced by the military judiciary in Jordan and directed by the General Intelligence Department, and under the confirmation of the regime and its henchmen on their historical and renewed hostility to the Khilafah State (Caliphate) on the method of the Prophethood, as well as their hatred towards those working for it - specifically the members of Hizb ut Tahrir, who are struggling for its return to the lives of Muslims in compliance to the commandment of Allah (swt): ﴿وَأَنِ احْكُم بَيْنَهُم بِمَا أَنزَلَ اللَّهُ وَلَا تَتَّبِعْ أَهْوَاءَهُمْ وَاحْذَرْهُمْ أَن يَفْتِنُوكَ عَن بَعْضِ مَا أَنزَلَ اللَّهُ إِلَيْكَ﴾ **“So judge between them by that which Allah hath revealed, and follow not their desires, but beware of them lest they seduce thee from some part of that which Allah hath revealed unto thee.”** [TMQ 5:49], the Jordanian State Security Court has once again committed a great sin, slander, and great injustice on Wednesday 13/9/2017, while the judges were indifferent to Allah’s promise to the unjust: ﴿وَلَا تَحْسَبَنَّ اللَّهَ غَافِلًا عَمَّا يَعْمَلُ الظَّالِمُونَ إِنَّمَا يُؤَخِّرُهُمْ لِيَوْمٍ﴾ **“AND DO NOT think that God is unaware of what the evildoers are doing: He but grants them respite until the Day when their eyes will stare in horror,”** [TMQ: 14:42], and unaware of the truth of Allah’s promise to the oppressed believers, to grant them inheritance (of power) and authority. Allah (swt) says: ﴿وَتُرِيدُ أَنْ نَمُنَّ عَلَى الَّذِينَ اسْتُضِعُوا فِي الْأَرْضِ وَنَجْعَلَهُمْ أَئِمَّةً وَنَجْعَلَهُمُ الْوَارِثِينَ﴾ **“And We desired to show favor unto those who were oppressed in the earth, and to make them examples and to make them the inheritors.”** [TMQ 28:5]. The court sentenced one of the members of Hizb ut Tahrir – Ustaadh Sa’eed Radwan (Abu Emad) to three years in prison on charges of belonging to an illegal organisation (Hizb ut Tahrir) and undermining the regime.

In the face of this incessant injustice, which the regime continues to impose on Hizb ut Tahrir and its members, a political party known by the far and near, we say the following:

**Firstly** – Hizb ut Tahrir is an Islamically legitimate party, whether people like it or not, it is a political party whose ideology is Islam, established in compliance with the command of Allah (swt): ﴿وَلَتَكُن مِّنكُمْ أُمَّةٌ يَدْعُونَ إِلَى الْخَيْرِ وَيَأْمُرُونَ بِالْمَعْرُوفِ وَيَنْهَوْنَ عَنِ الْمُنْكَرِ وَأُولَٰئِكَ هُمُ الْمُفْلِحُونَ﴾ **“Let there arise out of you a group of people inviting to all that is good, enjoining what is right, and forbidding what is wrong: They are the ones who are**

**successful.”** [TMQ 3:104] And it made it incumbent upon itself, while having full reliance on Allah (swt), to achieve its goal, challenging all obstacles and hardships, unheeding of the injustice of the oppressors, and not occupying itself with the ignorance of the ignorant, the hatred of the hateful, and the conspiracy of the mercenaries who have betrayed Allah (swt), His Messenger and the believers. There is no consideration, no value, and no weight for any law that describes Hizb ut Tahrir as an illegal organisation. Based on the statutes initiated and drafted by a handful of clients of the political Glubb Pasha and inheritors of the English in the hostility to Islam and the form of governance in the form of Khilafah.

**Secondly** – It has become known politically and worldwide that Hizb ut Tahrir is a political party working in politics, and is very far from material work or any violence, working for the resumption of the Islamic way of life for Muslims under the shade of the only ruling system that emanates from the Islamic Aqeedah in its rules, form and laws (the Khilafah), which was and will soon be by the will of Allah (swt) the political entity of the Muslim Ummah, the Messenger of Allah (saw) said: «... ثم تكون خلافة على منهاج النبوة»  
**“Then there will be a Khilafah on the method of Prophethood...”**

**Thirdly** – the accusation of undermining the regime, which has become the preamble of the regime to put the country's sincere in prison, but this is to be executed on the gangs of corruption and professional thieves from the regime's henchmen of economists, security personnel and political center, who looted the wealth of the people and the land and conspired to exploit its lands and security. The gangs formed under the eyes and ears of the regime, deriving their power from outside; including those who owe allegiance to America and carry out its political, security, economic and social agenda, and those who owe allegiance to the Jewish entity, implementing its political, security and economic agenda... In what balance does the regime weigh the actions of these gangs and in what perspectives? It is the balance of weakness that can only be implemented against the sincere; the members of Hizb ut Tahrir and other Muslims. Indeed, the eyes of injustice and darkness only see the danger of the caller of truth and goodness. Hizb ut Tahrir is the pioneer that does not lie to its people nor let them down or betray them, and only seeks strength from its Deen and Ummah for the sake of the Ummah's dignity, pride and glory...
