## The Hindu State Dared to Convene the G-20 Conference in Occupied Kashmir, Because the Rulers of Pakistan Restrain Our Willing Armed Forces through the Ceasefire on the Line of Control

The Hindu State is holding a three-day G-20 meeting from 22 May in Srinagar, Occupied Kashmir. It is another attempt to legitimize the Hindu State's oppressive occupation of Occupied Kashmir. The Hindu State dared to do so because the rulers of Pakistan have tied the hands and feet of our willing and capable armed forces, through the ceasefire agreement on the Line of Control. Had the Pakistan Army adopted an aggressive stance on the Line of Control, or had the jihad infrastructure in Occupied Kashmir remained intact, could India have even contemplated holding the G-20 conference in Srinagar? Absolutely, not. Now the rulers of Pakistan are using the refusal of China and some Muslim countries to participate in the G-20 conference in Occupied Kashmir as evidence of their success. However, this will not result in the reversal of the 5 August 2019 Indian forced annexation, or the liberation of Occupied Kashmir.

The fact is that the Pakistan rulers acted as facilitators for the Hindu State to hold the G-20 conference in Occupied Kashmir. When the Hindu State forcibly annexed Occupied Kashmir in August 2019, it was a clear violation of a red line. The Hindu State should have paid a heavy price with a jaw-breaking response. However, on the orders of their master America, instead of mobilizing the armed forces over the Line of Control, Pakistan's political and military leadership tried to cool the intense anger of the Muslims of Pakistan and their armed forces. They undertook token measures, such as renaming the Kashmir Highway in Islamabad as Srinagar Highway, showing Occupied Kashmir as part of Pakistan on Pakistan's official map, standing on streets wearing a black armband for a few minutes a week and making speeches at the United Nations. After that, the rulers of Pakistan facilitated the Hindu State. They signed a ceasefire agreement with on the Line of Control the Hindu State on 25 February 2021. They did so at the behest of their American masters ensuring the consolidation of the forced accession of Occupied Kashmir by Modi. It is this facilitation that gave the Hindu State the courage to hold the G-20 meeting in Occupied Kashmir.

For decades now, the political and military rulers of Pakistan have been deceiving the Ummah, regarding Occupied Kashmir. They claim that they will continue to provide political, moral and diplomatic support to the Kashmiri Muslims. Can oppression of the oppressed ever be ended by political, moral and diplomatic support alone? Absolutely, not. They also claim that they want to end the occupation by the Hindu State of Occupied Kashmir by the implementation of UN Resolutions. However, has it not been made clear that the United Nations is a colonialist tool? The UN only implements resolutions that are in line with the interests of the US and Western colonialist countries? Waiting for the implementation of UN resolutions will only facilitate the Hindu state by buying it more time to consolidate its occupation.
