## Hizb ut Tahrir's Delegation in Ukraine visits the Pakistani Embassy and Jordanian Diplomatic Representation

(Translated)

On 17/8/2018, a delegation from Hizb ut Tahrir in Ukraine consisting of three people visited the Pakistani embassy and the Jordan's Diplomatic representation in the city of Kiev. This visit comes as part of a global campaign carried out by Hizb ut Tahrir these days in many countries of the Islamic world and the world.

The reason for visiting the Embassy of Pakistan is to protest against the kidnapping of two Muslim women, who are from the Dawah carriers in Pakistan, in the past few weeks.

In the early morning of 30/7/2018, the Pakistani security services abducted the well-known Islamic teacher, Romana Hussein, a mother of four, from her house.

Two weeks later, i.e. on 13/8/2018, in the early hours of the morning, Pakistani security services broke into Dr. Roshan's house and kidnapped her and her husband. Dr. Roshan is well-known among the Muslim community in the city of Karachi for her speeches calling for the establishment of the second Khilafah Rashida on the method Prophethood.

Hizb ut Tahrir/ Wilayah of Pakistan, issued two press releases condemning the kidnapping of the two Muslim women by the Pakistani security services and demanding their release and the release of the husband of one of them immediately.

Hizb ut Tahrir's delegation in Ukraine visited the Embassy of Pakistan on the morning of 17/8/2018. The delegation was received by Mohammad Fahad, the diplomatic attaché of the mission of the Pakistani Embassy to Ukraine. The head of Hizb ut Tahrir's Media Office in Ukraine, Fadl Hamzayev, handed over the two press releases issued by Hizb ut Tahrir in Pakistan regarding the kidnapping of Romana Hussein and Dr. Roshan, and he explained the details of what had happened to them and what are Hizb ut Tahrir's demands. The diplomatic attaché, Mohammad Fahad, attentively listened to the delegation's words and promised to deliver their message and the press statements to the Government of Pakistan.

On the same day, after a visit to the Embassy of Pakistan, the delegation headed to the Hashemite Kingdom of Jordan's representation in Ukraine.

The reason for the visit is to protest against the arrest of Hizb ut Tahrir's member, Ismail al-Wahwah, in Jordan on 25/7/2018. He is a holder of the Australian nationality; he was arrested upon arrival at Amman's airport.

Hizb ut Tahrir in Australia and Jordan issued press releases about the incident and condemned the illegal arrest of Brother Ismail and demanded his immediate release.

Since Jordan does not have an embassy but a diplomatic representation, the delegation was received by the secretary of the representation who pledged to give the delegation's message and the press statements by Hizb ut Tahrir to the Kingdom's ambassador to the Russian Federation, who will in turn hand it over to the Jordanian Government.
